### Preschool Contribution

Preschool Contributions can be paid in full, via EFT or EFTPOS at our office- please check your invoice for due date.

### Between Session Care

**\$ 20.00 per session**

This will be provided by our Childcare Educators. Between Session Care Fees will be invoiced and emailed to our families each week for the previous weeks care, and the Direct Debit is processed every Thursday. The **RED** Direct Debit form available in your "Welcome Pack" must be completed and returned ASAP.

Our Centre is a Federal Government "approved child care service". Families may be eligible for Child Care Subsidy (CCS) and are required to register for CCS through their MyGov online account and confirm their child's enrolment. If eligible, your government approved entitlements for Child Care Subsidy is automatically deducted from your weekly fee and a GAP will be payable.

Long Day Care Fees will be invoiced and emailed to our families each week for the previous weeks care, and the outstanding balance is processed via Direct Debit every Thursday. The **RED** Direct Debit form available in your "Welcome Pack" must be completed and returned ASAP.

### Child Care Sessions in conjunction with Preschool

Before/After Preschool Care, Between Session Care and Lunch & Afternoon Care are Child Care sessions and are eligible for Child Care Subsidy.

If your child is booked into a session of care during the school term and is absent for any reason, an absence will be recorded and normal fees charged, however, fees for these sessions are NOT charged during school holidays, public holidays or on Preschool Closure days.

"Families can get Child Care Subsidy (CCS) when their child is absent from a session of care they would normally attend for up to 42 days per child, per financial year.

If your child is booked into more than one of the programs on the same day (such as Before and After Preschool Care) and is absent for one of those sessions, it is counted as one absence day".

Families can get extra absence days in certain circumstances.
